Section 240.13d-3, as of January 31, 2019, Mr. Cannell beneficially owns 2,568,446 shares. Mr. Cannell's interest in the securities reported herein is limited to the extent of his pecuniary interest in each of the Cannell Investment Vehicles, if any.
